



**Haydenville Congregational Church UCC
Children's and Youth Ministry Program Volunteer
Criminal Offender Record Information (CORI) Acknowledgement Form**

Haydenville Congregational Church UCC is registered under the provisions of MGL c.6, section 172 to receive CORI for the purpose of screening current and prospective volunteers.

As a current or prospective volunteer ("applicant"), I understand that a CORI request will be submitted electronically for my personal information to the Massachusetts Department of Criminal Justice Information Services. I hereby acknowledge and provide permission to Haydenville Congregational Church UCC to submit a CORI check for my information. This authorization is valid for one year from the date of my signature. I may withdraw this authorization at any time by providing Haydenville Congregational Church UCC with written notice of my intent to withdraw consent to a CORI check.

Haydenville Congregational Church UCC may conduct subsequent CORI checks within one year of the date this form was signed by me, provided that Haydenville Congregational Church UCC must first provide me with written notice of this check.

Notes:

- For the 2016-2017 Children's and Youth Ministry Program year, Rev. Chris Mereschuk will be submitting the CORI requests, and will be the sole keeper of all personal information, which will be kept in a location that is not publicly accessible.
- CORI reports will be considered valid for one year from the date that the CORI request has been submitted.
- Applicants may request in writing to Rev. Chris Mereschuk a copy of the CORI results.
- If CORI results return with anything other than a "clean" history, Rev. Chris Mereschuk (in consultation with Rev. Dr. Andrea Ayvazian and in conversation with the applicant) will determine the eligibility of the applicant as a volunteer for Haydenville Congregational Church UCC's Children's and Youth Ministry Programs.
