



Statement of Consent

"The United Church of Christ recognizes that God calls certain of its members to various forms of ministry in and on behalf of the church for which ecclesiastical authorization is required." United Church of Christ Constitution, Article VI, paragraph 21.

Use of the UCC Ministerial Profile signifies that an individual has an Association's ecclesiastical authorization to seek a call as a minister in and on behalf of the church; has completed background check screening and fitness verification; has attested to certain statements in a document of self-disclosure; and has gained three references which speak to her/his practice of ministry. The Profile is a tool of testament and transparency, meant to demonstrate covenants of supportive cooperation and appropriate sharing of information among national offices, Conference and/or Association personnel, calling bodies, and the minister, as expressed in paragraph 25 of Article VI of the United Church of Christ Constitution.

It is essential that information contained within this document be sensitively and responsibly reviewed and interpreted. All those seeing the document have the responsibility to maintain or dispose of its contents confidentially.

Any practice by calling bodies of routinely rejecting profiles on a perfunctory basis without a complete and individualized assessment, including a thoughtful review of commentary offered by the candidate, is strongly discouraged. In particular, criminal history information, including the conduct underlying that history, should be evaluated in terms of the nature and gravity of the offense or conduct, the time that has passed since the offense, conduct, and/or sentence, and the nature of the position sought by a candidate, so as to foster call and hiring decisions that are based on an individualized assessment that is job/ministry related and consistent with ministry/business necessity.

Relationships between calling bodies, authorized ministers, and those holding ministerial standing and fitness oversight rely upon practices of discernment and dialogue. Because such relationships require integrity and an honest exchange of relevant information, for the health and mission of the church, this minister pledges the following:

1. I attest that the information contained in the UCC Ministerial Profile is true and complete to the best of my knowledge. I understand that any misrepresentation or omission may be grounds for a calling body's declined consideration for, or termination of, a ministry position. I acknowledge that it is my duty in a timely manner to amend the responses and information I have provided if I come to know that a response or information was incorrect when given or if the response or information, though accurate when given is no longer accurate.

2. I understand that I may designate certain Conference and/or Association staff and other persons and entities, to receive and circulate my UCC Ministerial Profile. I authorize all such persons and entities, and/or their agents, to make inquiries regarding all statements contained in my UCC Ministerial Profile. I also authorize all persons, entities, former employers, committees on ministry and their agents, courts, law enforcement and other public agencies to respond to inquiries concerning me and to supply verification of the information provided in my UCC Ministerial Profile. I understand that such persons may comment on and state their opinions regarding my background and character to those who execute the search process, such as members of a calling body or judicatory staff persons. To encourage such persons to speak openly and responsibly, I hereby release them from all liability arising from their responses and comments made in good faith and without malice.

My sense of being called by God and the church to authorized ministry (from "Exhibiting a Spiritual Foundation and Ongoing Spiritual Practice" section).

I like many, was brought up in the church, in a small rural church with its roots in the Christian side of the Congregational/Christian church. In that tradition we practiced adult or of age baptism so at the age of 9 I was baptized and became a member of the church, however, it was not until the age of 15 that I had, what some would call, the Saul type conversion experience, at the same time I became affiliated with a nondenominational ministry whose founder and pastor was a woman name Cora Smith. I give credit to her and her ministry for my early spiritual development. At the age of 16 I felt the inner press to be more than what we are all called to be and that is witnesses to the gospel of Christ but to proclaim, to minister the gospel and I accepted that call. I became pastor of my first church at the age of 20, at the age of 30 I felt again a strong press to reconnect with the United Church of Christ so I entered seminary and was called to my first UCC congregation and have been a devoted, committed UCC pastor every since.

To me Covenant means that we are all in this thing together, as members of a local congregation, pastors,



associations, conferences and the national setting of the church. Covenant does not mean that we are cut with cookie cutters or that we rubber stamp anything in our covenanted relationship, but what it does mean is that while we celebrate our diversity and autonomy we agree to be the United and Uniting Church of Christ to work together for justice while spreading the gospel that is the good news of Christ's love.

I am passionate about preaching and about being with and serving God's people.

Reflect on your personal and professional formation for ministry in light of any mark from another section. A healthy sense of self as shaped by God, community, and personal experience. I am gay and I have been gay since before I knew what being gay was and being black and gay was a double whammy perhaps all over but particularly in the small town and community in the south where I grew up. Needless to say the community and the church fostered a very negative self-image within me and it caused me to struggle with my sexuality. I grew up hearing all of the condemning sermons and even after I was compelled into the ministry I struggled and did not understand how God could use me in ministry and condemn me at the same time. It was not until I was in my early twenties that I gained a positive sense of self. I will share with you how God brought that about: I was on my way home from a church service one Friday night very late, a service where I had heard yet another condemning sermon and it was all I could take and on the way home that night I had to cross a very well know bridge in NC and as I drove I was in tears and crying out to God and I said that if God did not do something before I got to that bridge I was going to drive my car over into the water beneath it. The bridge sat at to bottom of steep hill and when I crest the top of that hill to begin my decent a light surrounded my car and I heard God's voice say "you are my child and I love you" and it was that time that redefined who I was within but it did not change the church as I saw it. When I began to get more involved in the UCC and served on committees and boards on the association, conference and national level and particularly when I became a part of the staff of Back Bay Mission I was really opened up to not just the God who affirmed me but to know a church that affirmed me and finally developed a very healthy sense of self that I have maintained and for that I am thankful.

Role and Relationship to Minister

This minister's areas of strength in the practice of ministry as I experience them are

Preaching. Rev. Morgan exhibits the rare gift of being a preacher who is always true to who he is and yet he is always accessable to whoever the group is. Meaning that he can speak high to the rafters and fill forty-minutes minutes of time, or he can preach soft and melodic and say all there needs to be said in fifteen minutes. Rev. Morgan incorporates a deep understanding of Scripture with relatable stories and a rich baritone voice he often uses for song. He can make one think, laugh, cry and feel filled by the Holy Spirit, all while speaking the truth in love and giving a message that celebrates Jesus Christ.

Some areas for improvement in this minister's practice of ministry in my experience of them are

Understanding of office space and how one arranges or decorates their office does create an immediate impression. Rev. Morgan is not a man of expensive taste and flash, which is fine, but there can be an art form to simplicity and a stack of books that says "Welcome, sit." I chalk this up to Rev. Morgan being a man so focused on God and ministry that he does not always have the time or interest to arrange things. If it came to a stack of papers on his desk or helping someone put up a wall in their house, you can bet Rev. Morgan is going to be there with his hammer and nails.

Describe a significant experience you have had of this person in ministry

In 2013 I was invited to be part of a revival service at Rev. Morgan's church. While there, one of his elders was in hospice. I had the chance to go with Rev. Morgan and visit the man and his family. I was impressed with the gentle pastoral presence and authority Rev. Morgan exhibitied when he entered the man's room. It was clear that just his presence made his parishioners feel calmer. Rev. Morgan spoke to the man and his wife with great love and compassion. He did not sugar-coat things, yet he offered words of encouragement and hope. Becuase everything Rev. Morgan does is Christ-based and not ego-driven, he invited me to lead the family in prayer and it was one of those scared moments one does not forget. At their time of sadness, Rev. Morgan was a calm rock and made all those in the room feel at peace.

Additional Comments

I've known Rev. Morgan since 2002 when I visited Back Bay Mission as an Eden student. I worked alongside Rev. Morgan as we delievered refrigerators and fixed people's homes. He was patient and kind to me, even though I was not adept at manual labor and slower than everyone else. Later that year, Rev. Morgan took his sabbatical at Eden, attending classes/worship services. He encouraged of my pastoral gifts. I returned to Back Bay 3 more times and Rev. Morgan always treated me with respect. We've become peers, encouraging and supporting one another. He preached at my 1st installation service and so impressed the congregation (mostly made up of elderly Dutch folk) that they invited him back 2x more to preach. Rev. Morgan was also invited by the MI conference to be our annual meeting's guest preacher. He is a man who can preach the Gospel and then roll up his sleeves to do gospel.

Role and Relationship to Minister

This minister's areas of strength in the practice of ministry as I experience them are

This is in strong support of Pastor Don W. Morgan who I knew during his time at the Warren Congregational Church in Warren, Connecticut. Pastor Morgan's ministry here was defined by an effort to bring new ideas to the church service and experience, as well as, an energetic delivery of the biblical message. Pastor Don conducts a service and offers a style of sermon that wakens the spiritual soul and charges the spiritual batteries. He provides a welcoming and affirming church environment for all to find God. Pastor Don held Bible studies, introduced a new level of musical worship, and offered spiritual revivals, both at the Warren Congregational Church and at other area churches. All of this was offered with an understanding of our traditional New England ways, yet, politely challenging regular routine.

Some areas for improvement in this minister's practice of ministry in my experience of them are

I would liked to have seen Pastor Don's revival meetings develop to embrace the New England spirit, region and community. Pastor Don's heritage, and it might be fair to say that the revival meeting heritage, comes from Southern regions. I very much liked the idea of a revival meeting and encouraged the effort. However, New England is a difficult venue which usually requires some adaptation. I cannot give a specific example as to how to make that transition, not being a native born New Englander, and still looking for acceptance after 15 years of living here.

Describe a significant experience you have had of this person in ministry

Pastor Don is truly blessed with the Holy Spirit as his helper and personal guide. This is clearly evident in how he lead our church in the worship service and in his interaction with the congregation. We had several personal visits together and in small group gatherings. As I tried to move from industry to consulting, eventually leading into retirement, there were meetings and phone calls to discuss opportunities and direction. Sunday brunch, dinners sitting at his picnic table with the BBQ and restaurant experiences. I have always found him comfortable to talk with about life's issues, problems and concerns. Discussing the Bible with Pastor Don is a comfortable and educational experience. I know Pastor Don to be a warm and empathetic person and, if given the opportunity to come into your life, can provide a positive influence on you.

Additional Comments

Besides the opportunity to worship together in a Christian fellowship, I attend church to sing traditional and new to me hymns and to enjoy a sermon that is biblically based, spiritually challenging and renewing. I expect a sermon to inspire me and to lead me to a better understanding of what the Bible is trying to teach me by using scripture and relevant examples, yet, allowing me the freedom to search my own thoughts. I best appreciate a sermon that puts the message in the context of the biblical setting, and then extends that understanding to our current times with our current and traditional assortment of challenging problems and concerns. Pastor Don's leadership in service and



sermons consistently exceeded my expectations.

*Pastor Don is deeply spiritual and religious. He shares his faith effectively. His sermons are scripture-based, inspired and inspiring, and relevant. Frequently his message touches upon something that has been a concern for me. *We liberally apply UCC's motto "no matter who you are or where you are … you are welcome here". He adapted to the challenges of serving a congregation with broad interpretations of what it is to be a person of faith. He admits that some of his thinking has been challenged, but that his faith has also been broadened. Even so, Christ is obviously the prime influence of his faith journey *He rolls up his sleeves and works at dinners and other activities. *He is flexible and adaptable, assuming duties he was accustomed to having done by committees or clerical support. *He has actively promoted our church to increase awareness of who and where we are.

Some areas for improvement in this minister's practice of ministry in my experience of them are

I see an experienced, practiced minister in Pastor Don. He has been in the ministry for 30 years. Life is a process of changing and growing for all of us. We should always seek ways to improve ourselves. I believe he has grown through his experience with our church, and he will grow with each new experience. I can think of no particular areas of growth that he needs to work on.

Describe a significant experience you have had of this person in ministry

Pastor Don has a passion for Gospel music – something to which our congregation has not been exposed very much. He plays the piano and sings and has composed many Gospel songs. He started a Gospel choir soon after he came



to us. He does not require great singers; the only requirement is to love music and to sing out with joy. It took the choir members several sessions to "get into" the music, but it is joyous music to sing. It has been particularly rewarding to see the congregation smiling and swaying and clapping with the music. It added a new dimension to our worship experience.

Additional Comments

Our congregation hired Pastor Don in good faith in December 2013, knowing that we are a small church with financial issues, and believing that he could help us grow our membership and finances. Given the opportunity, I believe he could, for he has already brought some new faces to our church, and he has begun to implement some cost-saving measures as well as implementing an on-line donation capability. Unfortunately, we underestimated the extent of our situation. The cost of supporting a full-time pastor is too great for us to sustain. We love Pastor Don, and under normal circumstances we would choose to have him as our pastor for as long he chose to remain. But he and we must consider his well-being.

wonderful congregation, however they were having serious financial problems that were massed by a sizable endowment when they call me and after three years of living of the endowment the church closed. Then I was called to the Warren Congregational UCC, Warren, Ct., The Warren church was also a wonderful congregation but one that was not sure of its identity. They said when they called me that they were "An Open and Welcoming" congregation, that they welcomed anyone regardless of race, gender or sexual orientation into full membership of the church but that they would not allow same sex weddings (which were legal in CT) in the church or on church property, and that I could accept. I did not feel compelled to disclose that I was gay to the search committee. After about 1 year I made that disclosure to the Governing Board and was affirmed by each of them and about 1.5 years into my call a gay couple came to worship with us and the net week came to my office and asked if I felt that they would be welcomed as members of the church and I told them the church policy and they accepted it and joined the church but were not well received by some in the church even some in leadership positions and about 6 months as members this couple decided to celebrate 25

years together by getting married and asked me to officiate the wedding in their home and I consented to do so. Many in leadership in the church then turn on me and said that by officiating the wedding I affirmed the gay lifestyle and that the church had made it clear that it was not Open And Affirming and then they revisited the disclosure issue and said that I lied to the search committee and that was the beginning of the end of my ministry at Warren we just could not get pass all of that.
